**TERMS AND CONDITIONS OF CONTRACT (please initial all lines to show that you've read and you agree with the terms)**

- \_\_\_\_\_ We require a **non-refundable** deposit of 50% of the total cost to hold your date. The deposit is applied toward the final balance.
- \_\_\_\_\_ Weddings must be paid in full 14 days prior to wedding date. Date balance is due: \_\_\_\_\_
- \_\_\_\_\_ From the minute we arrive, we are on the clock. Please be ready at your scheduled time. If we have to wait for you to get ready, there will be an additional charge of \$50/hour.
- \_\_\_\_\_ The bride is ultimately responsible for all costs; we are not responsible if bridesmaids don't pay on time.
- \_\_\_\_\_ Completed waivers are **required** with the contract; no waiver, no service. We cannot hold a wedding date without a signed contract and deposit. **THERE ARE NO EXCEPTIONS.** There is a \$30 returned check fee. All further payments must be in cash.
- \_\_\_\_\_ We charge 150% for the following holidays: New Year's Eve, New Year's Day, Easter, Halloween, Thanksgiving, and Christmas.
- \_\_\_\_\_ After hair and makeup are finished, Trio will do a quick touch-up, then leave. If you wish for Trio to stay through picture taking, an additional cost can be discussed.
- \_\_\_\_\_ A travel fee may apply for both the event and trial-run.
- \_\_\_\_\_ "Fast track" weddings, those where we have two (2) weeks or less to organize the entire thing, must be paid in full in cash, cashier's check, or money order at the time of the trial run. All of the above still apply.

**CHANGES & CANCELLATION POLICY (please initial all lines to show that you've read and you agree with the terms)**

- \_\_\_\_\_ Any changes (additions or cancellations) to services **MUST** be disclosed at least two (2) weeks in advance of the wedding.
- \_\_\_\_\_ "Additional services" are any services added to the contract **AFTER** it's been signed. All additional services will be at full price. Payment for additional services is due on the day of the event (or sooner, if made before the 2-week mark) and must be in the form of cashier's check or money order. Payment is due **BEFORE** services will be provided. **NO EXCEPTIONS.**
- \_\_\_\_\_ There will be **NO REFUND** for individual services cancelled within two (2) weeks of the wedding.
- \_\_\_\_\_ There will be **NO REFUND** if you cancel **ALL** of your services with Trio within two (2) weeks of the event. If you cancel **ALL** services at least two (2) weeks before the wedding, you forfeit the deposit.
